OBJECTIVE

- 1. As a people called by God, who shall constitute part of the Body of Christ, built and established upon the foundation of the Apostles and Prophets, Jesus Christ Himself being the chief cornerstone and
- 2. Because members of the Body, the Church of Jesus Christ are enjoined to assemble themselves together for worship, fellowship, counsel and instruction in the Word of God and the work of the ministry, and for the exercise of those spiritual gifts and offices provided for in New Testament church order;
- 3. It is resolved that the Society is a Pentecostal denomination comprised of churches, credential ministers, and associated agencies who voluntarily enter into its membership based on mutual agreements, shared objectives and beliefs as stated in our Tenets of Faith for the purpose of:
 - **a)** Encouraging and promoting the spread of the Full Gospel in Singapore and beyond:
 - **b)** Providing a basis of fellowship among Christian ministers of like precious faith:
 - c) Establishing and maintaining Bible Schools and other educational institutions:
 - **d)** Promoting medical and other humanitarian institutions and enterprises; and
 - e) Promoting the distribution of Bibles and other fundamental Christian Literature.

- To recognise and promote scriptural methods and order of worship, unity, fellowship, work, and business for God and to disapprove unscriptural methods, doctrines and conduct.
- 5. To present a unified front that represents Pentecostal believers so there can be a united voice whenever and wherever needed and act in harmony in all matters of national scope which affect our religious life or violate our Tenets of Faith.
- 6. To gather for annual General Council meetings or such Meetings as required to formulate and state broad policies which will guide the Society and other related organisations of the Society.
- 7. To guard the Pentecostal testimony and promote establishment of selfpropagating and self-supporting local assemblies of Pentecostal believers in Singapore.
- 8. To provide and conduct religious services of the Christian faith and public worship services.
- 9. To have the right to receive or remove members and to mediate or to arbitrate and to resolve issues involving the members as necessary.
- 10. To grant credentials, to those who have met the requirements as set forth in the Constitution and By-Laws of the Society.
- 11. To have the right to own, hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of, such property real or chattel, as may be necessary for the propagation of its work.
- 12. To have the right to establish and develop churches, departments and institutions as may be deemed necessary in order to fulfil the objectives of the Society.

General Superintendent's Report

Assemblies of God of Singapore Annual General Meeting 2024

2023 marked our 95th year of the Assemblies of God in Singapore. At the start of the year, I shared from Isaiah 43:18-19, that God has "A Greater Tomorrow" for us. I believe that AG Singapore would experience New Breakthroughs, New Directions, New Openings, New Works, and a New Breath of Life.

How true that was for us as we hosted "Kingdom Momentum", the inaugural Asia-Pacific Missions Congress on July 20-21. The event saw meaningful times of exchange, empowerment, and equipping for missions. When we held our Ministers' Institute and Retreat (MIR) after a four-year hiatus, we saw an impressive attendance, surpassing previous years, with over 190 participants including families, speakers, and children.

For the first time in its history, MIR 2023 introduced a specialized Children's program, offering children engaging and age-appropriate spiritual content. This initiative enriched the children's experience and enabled parents to participate fully during the retreat.

2023 also marked the start of 10 years before the fulfillment of MM33. If we are to see the movement of healthy churches, discipleship, next generation, and church planting, we need to raise more workers for the ministry like never before. ACTS College continued to be our arm of training ministers, to empower and equip leaders. In 2023, we saw 14 graduates commissioned and released into the ministry. At our Credential Ceremony, we affirmed 19 exhorters, eight licensed ministers, one associate licensed minister, and three ordained ministers.

In fanning the global movement of prayer for the World AG Fellowship, AG Singapore played the main host and organizer for the Global Concert of Prayer 2023 – Fires of Revival, where AG churches around the world came together to pray for 50 hours continuously for revival in our nations. 150 AG Singapore ministers gathered in person on August 24 during the hours of 11am to 12 noon to pray for our nation.

Another significant "New" for us as AG Singapore is corporate spiritual promotion. At the 2023 World AG Congress hosted by Spain AG in Madrid from October 12-14, a new executive council was put in place. The General Superintendent of Singapore, Rev Dominic Yeo, was elected as the new Chairman of the World AG Fellowship, along with Rev Doug Clay of AG USA as the Vice Chairman and Rev Juan Carlos as the General Secretary. AG Singapore has become a model of learning. We may be a small nation, but that has never deterred us from being impactful.

We've stepped into God's Greater Tomorrow for us as a denomination in Singapore. Let's 'Brace for Kingdom Impact' as we forge forward in the various movements of MM33 to see a great revival in and through our ministries!
